1. The Kyrgyz Republic has received financing from Asian Development Bank (ADB) toward the cost of **Strengthening Education System Sector Development Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Ministry of Education and Science of the Kyrgyz Republic** (the Purchaser), invites sealed bids from eligible Bidders for supply of **ICT equipment for multimedia classes in 30 innovative secondary schools and 7 Institutions of Teachers' Advanced Training in the Kyrgyz Republic** (the Goods).

3. **International Competitive Bidding** (ICB) will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- Minimum average annual turnover of **USD 2,100,000** calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 (three) years;
- Contractual experience - Successful completion as main supplier within the last 3 (three) years, of at least 2 (two) contracts valued at **USD 850,000** with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).

The qualification criteria are more completely described in the Bidding Document.
