



## Invitation for Bids – Rebidding

1. The Kyrgyz Republic has received financing from Asian Development Bank (ADB) toward the cost of **Skills for Inclusive Growth Sector Development Program**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Ministry of Education and Science of the Kyrgyz Republic** (“the Purchaser”) invites sealed bids from eligible bidders for **Procurement of Furniture for 7 Centers of Excellence classrooms and dormitories**. The bidding covers four (4) lots:

- Lot 1: Procurement of furniture for classrooms and dormitories of 2 Centers of Excellence located in Bishkek and Tokmok
- Lot 2: Procurement of furniture for classrooms and dormitories of 2 Centers of Excellence located Kara-Balta and Balykchy
- Lot 3: Procurement of furniture for classrooms and dormitories of 2 Centers of Excellence located in Kyzyl-Kiya and Osh
- Lot 4: Procurement of furniture for classrooms and dormitories of 1 Center of Excellence located in Zhalal-Abad

The Bidders can bid for any single lot, or a combination of lots, and consequently the Purchaser will evaluate and compare bids on the basis of a lot, or a combination of lots, or as a total of lots to arrive at the least cost combination for the Purchaser by taking into account discounts offered by Bidders in case of award of multiple contracts.

3. **Open Competitive Bidding** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- Minimum average annual turnover of calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years:
  - **Lot 1: KGS 15,000,000.00**
  - **Lot 2: KGS 13,500,000.00**
  - **Lot 3: KGS 17,000,000.00**
  - **Lot 4: KGS 12,500,000.00**
  
- Successful completion as main supplier within the last five (5) years of at least one (1) contract with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply), valued at:
  - **Lot 1: KGS 12,000,000.00**
  - **Lot 2: KGS 11,000,000.00**
  - **Lot 3: KGS 14,000,000.00**
  - **Lot 4: KGS 10,000,000.00**

The qualification criteria are more completely described in the Bidding Document.
