1. The Kyrgyz Republic has received financing from the Asian Development Bank (ADB) towards the cost of **Skills for Inclusive Growth Sector Development Program**. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.
2. The **Ministry of Education and Science of the Kyrgyz Republic** (the “Employer”) now invites sealed Bids from eligible Bidders for **Civil Works on Rehabilitation of Centers of Excellence in Balykchy City and Karabalta City**.
3. **National Competitive Bidding** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

The contract is expected to be completed within 240 days plus Defect Notification Period of 365 days.

4. Only eligible Bidders with the following key qualifications, should participate in the bidding:
 - Average annual construction turnover for the last three (3) years (2016, 2017, 2018) : equal to or more than KGS 140,000,000.00.
 - Should have completed at least two (2) similar works during the last five (5) years (2015, 2016; 2017; 2018; 2019) with value not less than KGS 56,000,000.00.

The qualification criteria are more completely described in the Bidding Documents.

5. Interested eligible Bidders may obtain further information from the Employer and inspect the Bidding Document at the address given below (para 6) from 9:00 hours to 17:00 hours; Monday to Friday.

8. Bids must be delivered to the address above (para 6) **at or before 15:00 hours Bishkek time on or before 18 March 2020.**

All bids must be accompanied by a Bid Security of the amount KGS 700,000.00 or its equivalent in a convertible currency. Late bids shall be rejected.

Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address above (para 6) at 15:30 hours on 18 March 2020. The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of bids.
