1. The Kyrgyz Republic has received financing from the Asian Development Bank (ADB) toward the cost of **Second Vocational Education and Skills Development Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.

2. The **Agency for Primary Vocational Education under the Ministry Education and Science of the Kyrgyz Republic** (the “Purchaser”) now invites sealed Bids from eligible Bidders for the **Procurement of Training equipment and facilities for 4 Vocational Schools of the Kyrgyz Republic**. The bidding covers two (2) lots and bidders may bid for one or both lots, as further defined in the bidding document. Bidder wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided that those discounts are included in the Letter of Bid.

- Lot 1 - “Procurement of training equipment and facilities for repair of vehicles” VESDP/ ICB/PG-18/002/1
- Lot 2 - “Procurement of training equipment and facilities for repair of agricultural machinery” VESDP/ ICB/PG-18/002/2

Goods supplying shall be completed within 120 days after the date of signing the Contract Agreement. The technical requirements of the supply are contained in Section VI: Schedule of Supply.

3. **International competitive bidding** will be conducted in accordance with ADB’s [Single Stage: One-Envelope](#) bidding procedure.

4. Only eligible bidders with the following key qualifications should meet the following requirements:

- a) Minimum average annual turnover calculated as payments received by the Bidder for contracts completed or under execution over the last 3 years shall be:
 - For Lot 1 – USD 650,000.00 (or equivalent in KGS)
 - For Lot 2 – USD 1,800,000 (or equivalent in KGS)

For bidder/s of multiple lots, the aggregated average annual turnover over the last 3 years will be assessed.

b) For each lot, the Bidder shall have at least one (1) similar contract successfully completed as main supplier within the last 3 years valued at:

- Lot 1 - USD 260,000.00
- Lot 2 - USD 720,000.00

Late bids shall be rejected. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below at 15:00 hours (Bishkek time) on 30 March 2018.

8. The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.
