1. The Lao People's Democratic Republic has received a financing from the Asian Development Bank (ADB) toward the cost of **Fourth Greater Mekong Subregion Corridor Towns Development Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. The **Ministry of Public Works and Transport** ("the Employer") through the Department of Housing and Urban Planning invites sealed bids from eligible Bidders for the **PS-CW03-Lot 2: Thakhek Municipal Solid Waste, in Thakhek city, Khammouane Province** ("the Works"). Contract duration is 730 days and the defect liability period is 365 days.

3. **International Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible source countries of ADB as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualification should participate in this Bidding:

- **Contract of Similar Size and Nature:** Participation in at least two (2) contracts, as main contractor (including as JV partner) or subcontractor, that have been successfully completed within the last five (5) years and that are similar to the proposed works where the value of the Bidder's participation for each contract exceeds USD3.6 million.
- **Construction Experience in key activities:** Key experience in (i) Install HDPE geomembrane for cell liners, (ii) Excavate and fill soil of similar landfill size, (iii) Supply and install 250 kVA or higher capacity transformer and 22 KV or higher power line network, and (iv) Construct bituminous surface treatment road or asphalted road and reinforced concrete pavement road.
- **Financial Capacity:**
 - The Bidder shall demonstrate that its financial resources meet or exceed the total requirement for the subject contract of USD560,000.
 - The audited balance sheets or other financial statements acceptable to the Employer, for the last three (3) years (2017, 2018 and 2019) shall be submitted and must demonstrate the current soundness of the Bidder's financial position.

- As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive
- Minimum average annual construction turnover of USD4.50 million calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.

The qualification criteria are more completely described in the Bidding Document.

The Employer will assume no liability for loss or late delivery.

7. Bids must be delivered to the address below **on or before 14:00 hours on 14 January 2021**. Electronic bid submission will not be permitted. Late bids will be rejected. Bids will subsequently be opened in public in the presence of the Bidders' designated representatives at the address below. All bids must be accompanied by a Bid Security as described in the Bidding Document.
