1. The **Government of the Lao People's Democratic Republic** has received financing from the Asian Development Bank (ADB) toward the cost of **Improving the Quality of Health Care Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Ministry of Health** (the "Purchaser") invites sealed bids from eligible Bidders for the for the supply of **various vehicles** (the "Goods"). Please see details below:

3. The number of lots comprising this bidding process is: Three (3). A Bidder may tender for one or more lots. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid.
4. **National Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
5. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

Financial Capability: The Bidder shall furnish documentary evidence that it meets the following financial requirement(s):

- A (credit) statement from Bank [name of bank, country] that covers not less than 60% of the quoted Contract Price.

And/or



- Audited financial statements that show an average annual turnover at least three times the quoted Contract Price.

[Note: Average annual turnover is calculated as total payments received by the Bidder for contracts completed or under execution over the last two (2) years].

Experience and Technical Capacity: The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

- Successful completion as main supplier within the last three (3) years, of at least two (2) contracts each valued at 80% of the estimated value of the subject contract with nature, and complexity similar to the scope of supply described in Section 6.

Late bids will be rejected. Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who choose to attend at the address below **14:00 Hours (Lao People’s Democratic Republic Time) on 20 June 2024**.
