



Invitation for Bids – Rebidding

1. Republic of Maldives has received financing from Asian Development Bank (ADB) toward the cost of the **Kulhudhuffushi Harbor Expansion Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Ministry of Finance and Treasury, on behalf of the Ministry of Housing and Infrastructure** (“the Employer”) invites sealed bids for the **Harbor Construction (the Works)**. Completion period is 15 months after signing of the contract.

3. **International competitive bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all bidders from eligible source countries as described in the Bidding Document.

5. To purchase the Bidding Document in English, eligible bidders should:

- Write to the address above requesting the Bidding Document for “H-01: Harbor Construction”
- The Bidder shall pay a non-refundable Registration fee of **MVR 1,500/- (Maldivian Rufiyaa One Thousand Five Hundred or equivalent in US dollars)** for the project from **26 August to 19 September 2018 between 0830hrs to 1200hrs on all working days**, cash or by demand draft drawn in favor of the “Ministry of Finance and Treasury” from any reputable bank in the Republic of Maldives.
- Bidding Documents can also be downloaded from Ministry of Finance and Treasury website www.finance.gov.mv from 15 August 2018 to 19 September 2018 **at no cost**. The bidder can submit its bid using the downloaded bidding documents. In this case no

payment towards the cost of the bidding documents is to be made by the bidder. Eligible bidders who download the bidding document from the MoFT website shall inform MoFT in writing (and provide their contact details) at the address given above, failing which MoFT shall not be responsible if the bidder does not receive clarifications and amendments, if any.

7. A pre-bid meeting will be held on 6 September 2018, 11:00 hrs. Maldivian time at the National Tender Meeting Room of the Ministry of Finance and Treasury.
