1. The Republic of Maldives has received financing from the Asian Development Bank (ADB) toward the cost of **Greater Male’ Environmental Improvement and Waste Management Project** and part of this financing will be used for payment under the Contract Package named above.

2. The Ministry of Finance, on behalf of Ministry of Environment, Climate Change and Technology (“the Employer”) re-invites sealed bids from eligible Bidders for the **Procurement of Goods (Multiple Lots): Three Outer Island Waste Collection Vessels - Retender** with the following details:

- LOT 1: Vessel 01**
- LOT 2: Vessel 02**
- LOT 3: Vessel 03**

3. International Competitive Bidding (ICB) will be conducted in accordance with ADB’s [Single Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Size of Operation (Average Annual Turnover): Minimum average annual turnover of:

- For bidders applying for 01 lot: USD 4,400,000
- For bidders applying for combination of 02 lots: USD 7,100,000
- For bidders applying for all 03 lots combined: USD 8,100,000

calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years (2018, 2019, 2020).

Contractual Experience

- Successful completion as main supplier for Bidders applying for 1 lot only: at least two (2) contracts within the last five (5) years, each valued at USD 1,500,000 with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply):
- Successful completion as main supplier for Bidders applying for any combination of two (2) lots only: at least two (2) contracts within the last five (5) years, each valued at USD 3,000,000 with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply): or any three (3) contracts successfully completed within the past five (5) years totalling USD 6,000,000
- Successful completion as main supplier for Bidders applying for all three (3) lots: at least two (2) contracts within the last five (5) years, each valued at USD 4,500,000 with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply): or any three (3) contracts successfully completed within the past five (5) years totalling USD 9,000,000.

6. Interested Bidders shall register with the Ministry of Finance, from **21 April 2022 to 27 June 2022 between 8:00 hours and 14:00 hours (9:00 hours and 13:00 hours during the month of Ramazan)** by:

- payment of a non-refundable Registration fee of **MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00 (United States Dollar One Hundred)**, through our online payment portal - **Ban'deyri Pay** (<https://bandeyripay.finance.gov.mv/>), or by electronic transfer to a designated bank account, information of which can be requested through email to above given email addresses, and;
- Once the payment has been confirmed, the Bidder shall be registered upon submitting in person or by electronic mail, the following information:
 - Name and Address of the Bidder
 - Name, Email address and contact number of the Contact Person(s)
 - Copy of the Payment/Transaction Receipt.

7. A complete set of Bidding Documents and related documentation shall be available on the Ministry of Finance website www.finance.gov.mv for downloading. The Ministry of Finance shall not be held liable for any information not received by the Bidder, and it is the Bidder's responsibility to verify the website for the latest information related to this invitation for bid.

A pre-bid meeting will be held online, details of which will be provided to all registered Bidders as well as Bidders who submit by email their interest to attend the meeting before 14:00 hours on 9 May 2022. - together with bid security as described in the Bidding Document

Late bids will be rejected. Bids will be opened immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend.
