



## Invitation for Bids

1. The **Government of Mongolia** received financing from the Asian Development Bank (ADB) toward the cost of **Fifth Health Sector Development Project**, and it intends to apply part of the proceeds of this loan to payment under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Ministry of Health** (MOH) (“the Purchaser”) invites sealed Bids from eligible Bidders for the **supply, delivery and installation of medical equipment for centralized sterilization service departments (CSSDs) of 20 project hospitals** (4 tertiary level hospitals, 3 regional diagnostic and treatment centers, 7 district general hospitals in Ulaanbaatar and 6 aimag general hospitals) in Mongolia. The contract package consists of modern equipment for decontamination, assembling and packaging, sterilization and storage and water treatment system for CSSDs. The bid has three (3) lots, as follows:
  - Lot 1: Equipment for Decontamination, Assembling and Packaging
  - Lot 2: Equipment for Sterilization and Storage
  - Lot 3: Water reverse osmosis systemThe delivery/completion period is four (4) months from signing date of the contract. A Bidder may bid for any one, more than one, or all the lots.
3. **International Competitive Bidding** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
  - a. Net worth for the last year calculated as the difference between total assets and total liabilities should be positive;
  - b. Minimum average annual turnover of
    - US\$2,700,000 for Lot 1
    - US\$4,800,000 for Lot 2

- US\$600,000 for Lot 3  
calculated as total payments received by the Bidder for contracts completed or under execution over the last three years (2015, 2016, and 2017).
- c. Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is
  - US\$ 1,100,000 for Lot 1
  - US\$ 1,900,000 for Lot 2
  - US\$ 250,000 for Lot 3
- d. Successful completion as main supplier within the last three years (2015, 2016 and 2017) of at least 2 contracts each valued at:
  - US\$ 1,400,000 for Lot 1
  - US\$ 2,500,000 for Lot 2
  - US\$ 330,000 for Lot 3with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).

Bidders should refer to the Bidding Documents for detailed qualification requirements.

5. Pre-bidding meeting shall be held on 25 December 2017 at 15:00 hours at the below address (para.7).
