- 1. The Government of Mongolia has received financing from the Asian Development Bank (ADB) toward the cost of **Sustainable Tourism Development Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The **Ministry of Environment and Tourism** ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of W2: Road link between the town center and local tourism roads, road sealing works from Khatgal to Jankhai, and car parks at Khatgal ("the Works")

- 3. **Open competitive bidding with international advertising** will be conducted in accordance with ADB's <u>Single-Stage: One-Envelope</u> bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Contracts of Similar Size and Nature	Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one contract that has been successfully or substantially completed within the last 5 (five) years (2016-2020) and that is similar to the proposed works, where the value of the Bidder's participation exceeds USD 8.5 million (eight and half million)	
Construction Experience in Key Activities	Participation in one contract within last 5 (five) years (2016-2020) for construction of an asphalt paved road having length at least 30 km x 2 lanes or 15 km x 4 lanes in a location having severe cold winters and short summer working season similar to Mongolia Road construction experience of application of geo cell and geotextile technology in the pavement structure of the roads	

The following special licenses are required for execution of the above-mentioned road construction works in territory of Mongolia are: Clause **2.8.2.1** – Construction of paved road issued by the order No. 131 by Minister for Road and Transport Development in 2018 or Clause **2.8.2.1.3** - Construction of paved roads with the length of 15km and above issued by the order A/123 by Minister for Road and Transport Development of Mongolia in July 2020.

The licenses shall be valid during the bid validity period. If the licenses are expired during this period, the decision of relevant authorities on extension of the license shall be submitted prior to expiration of the above-named licenses. Such licenses shall not be required from foreign bidders. Foreign bidders shall associate with national bidders as either (i) partners in the form of joint venture, or (ii) sub-contractors, who possesses the above mentioned and valid licenses. Any bid not accompanied by the compliant licenses shall be rejected by the Employer as nonresponsive
