



## Invitation for Bids

1. The Republic of the Union of Myanmar has received financing from the Asian Development Bank (ADB) toward the cost of **Mandalay Urban Services Improvement Project (MUSIP)**, and it intends to apply part of the proceeds of this financing to payment under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Mandalay City Development Committee (MCDC)** (“the Purchaser”) invites sealed bids from eligible Bidders for the Provisions of Community Based Solid Waste Equipment (“the Goods”) which includes the following:

### **LOT 1 – 7 Vehicles**

Supply and Delivery of Seven (7) Vehicles (Lift Trucks and Backhoe Loaders) with spare parts and warranty services

### **LOT 2 – 19 Containers**

Supply, delivery, Unloading, Installation, and Calibration/Testing of Two (2) Containers  
Supply, delivery, Unloading, Installation of Seventeen (17) Roll-On / Roll-off Containers

Bidders can bid for one (lot 1 or lot 2) or two lots (lot 1 and lot 2), but must offer the whole of the quantity or quantities indicated in the selected lot as the quantities indicated for the lots is indivisible. Under no circumstances must Bidders be considered for the part of the quantities required.

3. **National Competitive Bidding (NCB)** will be conducted in accordance with the ADB’s [Single Stage – One Envelope](#) procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

### Financial Situation

Minimum average annual turnover of Lot 1: 1,000,000 USD and Lot 2: 1,000,000 USD, calculated as total certified payments received for contracts completed or under executed over the last three (3) years.

### Experience

- General Experience: Experience under contracts in the role of main supplier for at least the last five (5) years prior to the applications submission deadline.
- Specific Experience: Participation as main supplier in at least one (1) contract within the last five (5) years, each with a value of at least Lot 1: 500,000 USD and Lot 2: 350,000 USD
