1. The Government of Nepal has received a grant from the Asian Development Bank (ADB) towards the cost of the **South Asia Tourism Infrastructure Development Project**. Part of the grant will be used for payments under the contract named above. Bidding is open to all bidders from eligible source countries of the ADB.

2. The **Ministry of Culture, Tourism and Civil Aviation** (the “Purchaser”) invites sealed bids from all eligible bidders for the **Supply of Electric Vehicles** (the “Goods”). Delivery period is 270 days.
