



## Invitation for Bids

1. The Government of Nepal has received a financing from the Asian Development Bank (ADB) toward the cost of **Disaster Resilience of Schools Project (DRSP)**. Part of this financing will be used for payments under the contracts named above. Bidding is open to bidders from eligible source countries of ADB.

2. The **Central Level Project Implementation Unit (Education), National Reconstruction Authority (NRA)** (the “Employer”) invites sealed bids from eligible bidders or joint ventures for the **Retrofitting of 14 School Buildings** in Kathmandu and Bhaktapur Districts. Retrofitting period is 18 months.

3. Only eligible bidders with the following key qualifications should participate in the bidding:

Technical bids will be opened immediately in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsible and Qualified Bidders shall be opened after Technical Bid Evaluation, whereas, the Financial Bids of those Bidders whose Technical Bids are not responsive and qualified shall be returned unopened after the contract is awarded.
