1. The Government of Nepal has received a financing from the Asian Development Bank (ADB) toward the cost of **Disaster Resilience of Schools Project (DRSP)**. Part of this financing will be used for payments under the contracts named above. Bidding is open to bidders from eligible source countries of ADB.

2. The **Central Level Project Implementation Unit (Education), National Reconstruction Authority (NRA)** (the “Employer”) invites sealed bids from eligible bidders or joint ventures for the **Construction of School buildings, Toilet and Water Supply facilities including site development works in 15 (Fifteen) schools** in Sindhuli District. Construction period is 18 months after contract signing date.

3. **Open competitive bidding (OCB) with international advertising** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.
