



## Invitation for Bids

1. The Government of Nepal has applied for financing from Asian Development Bank (ADB) toward the cost of **Electricity Grid Modernization Project**. Part of the loan will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Nepal Electricity Authority** (“the Employer”) invites sealed bids from eligible Bidders for the **Design, Supply, Installation and Commissioning of 132kV Transmission Line Conductor Upgrading**.

3. **Open Competitive Bidding (international advertisement)** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Bidders shall have minimum average annual turnover of US\$ 13.6 Million. Bidders are required to have satisfactory experience of at least two (2) contracts that have been successfully or substantially completed within the last ten (10) years and that are similar to the proposed contract, where the value of the Bidder’s participation in each Contract exceeds US\$ 13.0 Million. Out of the two (2) Contracts, one (1) should have been executed outside the Bidder's home country.

6. To purchase the Bidding Documents in English, eligible Bidders should:
- Write to address above requesting the above-mentioned Bidding Documents for ***PMD/EGMP/TLUP -077/78-01: Design, Supply, Installation and commissioning of 132kV Transmission Line Conductor Upgrading***. If the Bidder is purchasing the Bidding Document through their Local representative, an authorization letter shall be submitted indicating authority delegated to the local representative.
  - Pay a non-refundable fee of NRs. 20,000.00 or an equivalent amount in US\$ by bank voucher to the Account No. 00101500014600000104 (NEA-PROJECT MANAGEMENT DIRECTORATE) at the NMB Bank Limited, Babarmahal, Kathmandu, Nepal.

7. Deliver your bid:
- to the address above
  - on or before the deadline: **10 December 2020, 12:00 hours Nepal Standard Time (NST)**
  - together with the bid security as described in the Bidding Documents Section 2 Bid data Sheet, Clause ITB 21.1.

Technical Bids will be opened at the Project Manager's Office on 10 December 2020 at 12:30 hours (Nepal Standard Time) in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas the financial bids of those Bidders whose technical bids are not responsive and qualified shall be returned unopened after the contract is awarded.

8. When comparing bids, ADB's Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Bidding Document.
