1. The Islamic Republic of Pakistan has applied for financing from the Asian Development Bank (ADB) toward the cost of **Peshawar Sustainable Bus Rapid Transit Corridor Project**. Part of this financing will be used for payments under the contract named hereunder. This contract will be jointly financed by Agence Française de Développement (AFD). No nationality restrictions apply other than any restriction arising from ITB 4.7.

3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB’s [Single-Stage: Two Envelope](#) bidding procedure and is open to Bidders without nationality restrictions.
