- The Government of Sindh has received financing from the Asian Development Bank (ADB) toward the cost of **Sindh Secondary Education Improvement Project - SSEIP**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to bidders from eligible source countries of ADB.
- The **Sindh Secondary Education Improvement Project – SSEIP, SE&LD, Government of Sindh** (“the Employer”) invites sealed bids from eligible bidders for the **construction and completion of the following Works of Package-CW03: Construction of 37 new secondary level school blocks in 05 Districts including installation of solar panel:**

Package-CW03, LOT-01:
Construction of 20 new secondary level school blocks including solar panels in District Umerkot - 16 schools, District Tharparkar - 04 schools

Package-CW03, LOT- 02:
Construction of 17 new secondary level school blocks including solar panels in District Tando Allahyar - 08 schools, District Tharparkar - 04 schools, District Sanghar - 03 schools, District Sujawal - 02 schools

Bidders may bid for one or both lots, as described in the Bidding Documents.
- Open Competitive Bidding (National advertisement)** will be conducted in accordance with the [ADB’s Single Stage – Two Envelope](#) procedure and is open to all bidders from eligible countries as described in the Bidding Document.
- Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

Technical Experience Requirements:

- Participation as a contractor, Joint Venture partner, or Subcontractor, in **at least one (1) contract** that has been satisfactorily and substantially completed within the **last**

eight (8) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds amounts mentioned below.

Lot-01: PKR 1,975 Million or equivalent to US\$ 6.8 Million

Lot-02: PKR 1,680 Million or equivalent to US\$ 5.8 Million

The similarity of the Bidder's participation shall be based on physical size, nature of works, complexity, methods, technology and other characteristics as described in Section 6, Employer's Requirements.

Financial Experience Requirement:

- Audited financial statements for the last three (3) years, calculated as the difference between total assets and total liabilities, should be positive.
- Minimum average annual construction turnover, calculated as total certified payments received for contracts in progress or completed, within the last five (5) years: Lot-01: 3,000 Million or equivalent to US\$ 10 Million, Lot-02: 2,520 Million or equivalent to US\$ 8.6 Million.
