1. The Government of Sindh has received financing from the Asian Development Bank (ADB) toward the cost of **Sindh Secondary Education Improvement Project - SSEIP**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to bidders from eligible source countries of ADB.
2. The **Sindh Secondary Education Improvement Project – SSEIP, SE&LD, Government of Sindh** (“the Purchaser”) invites sealed bids from eligible bidders for **Supply and Installation of Optical Mark Reader (OMR) including Software, Computer, Printers and UPS and training of the staff regarding their usage etc.**

The Optical Mark Recognition Systems (OMRS) including Software, Computers, Printers and UPS shall be procured as under:

Bidders shall submit their bid for all items.

3. **Open Competitive Bidding (International advertisement)** will be conducted in accordance with the ADB’s [Single-Stage: One-Envelope](#) procedure and is open to all bidders from eligible countries as described in the Bidding Document.
4. The Bidders must satisfy the evaluation and qualification criteria in Section 3 of the Bidding Documents for each Lot of the subject Bidding Document in which they wish to participate, including the following key requirements:

Technical Experience Requirements: The Bidder shall demonstrate that the goods offered have:

- been in production for at least three (3) years

- been sold a minimum of ten (10) units of similar type and specification over the last three (3) years
- been in operation for a minimum of three (3) years.

Financial Experience Requirement: Audited financial statements for the last three (3) years, calculated as the difference between total assets and total liabilities, should be positive.

For the complete eligibility and qualification requirements, bidders should refer to the Bidding Document.

5. The delivery period is sixty (60) days for CIF (**Karachi**) / **EXW**¹ Pakistan (*excluding 20 days for inland transportation in case of Ex-Works delivery for Goods supplied from within Pakistan*) contracts respectively from the date of signing of contract.

No liability will be accepted for loss in transit or late delivery.
