1. The Islamic Republic of Pakistan has received financing from the Asian Development Bank (ADB) toward the cost of Emergency Flood Assistance Project (EFAP). Part of this financing will be used for payments under the Contract named above. This contract will be financed by Asian Development Bank. The eligibility rules and procedures of ADB will govern the prequalification and the bidding process.
2. The **National Highway Authority** (the “Employer”) intends to prequalify firms for **Repair/Rehabilitation and Reconstruction of Flood Affected/Damaged Three (3) Bridges on N-25 and N-50**.
3. It is expected that the Invitation for Bids will be made in **June 2023**.
