



## Invitation for Bids

1. The Government of the Republic of the Philippines has applied for financing from the Asian Development Bank (ADB) toward the cost of the **Malolos-Clark Railway Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Department of Transportation** (the Employer) through **Procurement Service, Department of Budget and Management** (the “Procurement Agent”), invites sealed bids from eligible Bidders for the construction and completion of the Works as broadly described below:  
  
Package CP S-01: Building and Civil Engineering Works for Approximately 1 Km of Viaduct Structure including Station Building at Blumentritt.
3. **Open Competitive Bidding – International** will be conducted in accordance with ADB’s Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

<b>Financial Standing</b>	Average Annual Construction Turnover	Bidder must have a minimum average annual construction turnover of Two Hundred Forty Million US Dollars (US\$ 240,000,000) calculated as total certified payments received for contracts in progress or completed, within the last five (5) years. Note: the number of JV partners shall be limited to three (3). [Ref: Item Section 2.3.2]
	Available Financial Resources	Bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of Sixteen Million US Dollars (US\$ 16,000,000). [Ref: Item Section 2.3.3]

Key Qualifications		Criteria
Financial Standing	Experience Contracts of Similar Value	Participation as a contractor, JV partner, or subcontractor, in at least two contracts that has been successfully or substantially completed between 1st January 2008 and deadline of Bid submission and that is similar to the proposed works, where the value of the Bidder's participation exceeds US Dollars One Hundred Twenty Million (US\$ 120,000,000). The similar work shall mean the project including the following works: 1. Road or Railway project of continuous nature. [Ref. Item Section 2.4.1]
	Bid Security	Bidder shall furnish a bid security in the amount of US Dollars Three Million (US\$ 3,000,000.00). [Ref: Section 2 Datasheet, ITB 19.1]
Resources	Equipment to be Allocated	Bidder must demonstrate that he has adequate equipment to meet, 1) the employer's quality and safety requirements, and 2) project timelines. [Vol 2, Sec 6]
	Personnel Assigned	Bidder must demonstrate that he has adequate Staff to meet 1) the employer's quality and safety requirements, and 2) project timelines. [Vol 2, Sec 6]
Specific Experience*	Steel Bridge	Bidder must have experience of construction of steel girder bridge of at least 50m length using incremental launching method.
	Elevated Railway Station	Bidder must have experience of at least one (1) project that included the construction of an elevated railway station in an urban area.
	Viaducts	Bidder must demonstrate he has experience of building Viaduct works for Railway or Road (Expressway or Motorway) more than 2 km using P.C. segmental span by span techniques. Relevant works will also include bored or pre-cast piling, R/C pile caps and piers constructed.
	Balance Cantilever Bridge	Bidder must have experience of constructing 3-span balanced cantilever bridges of at least 150m length using traveler formwork.

  - Pay a non-refundable fee of Philippine Peso Fifty Thousand (PhP50,000.00) or equivalent USD on the date of the payment for each of the Bidding Documents required, by cashier's check made payable to the Procurement Agent. Cash payments at the above address are acceptable subject to issuance of an authenticated official receipt.
