1. The Government of the Philippines has applied for financing from the Asian Development Bank (ADB) toward the cost of **South Commuter Railway Project**, and it intends to apply part of the proceeds of this financing to payments under the contract package CP S-02 named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Department of Transportation (DOTr)** (the “Employer”) through its Procuring Agent, Procurement Service (PS) of the Department of Budget and Management (DBM), invites sealed bids from eligible Bidders for the construction and completion of the Works as broadly described above.
3. **Open Competitive Bidding (International Advertisement)** will be conducted in accordance with [Single-Stage: One-Envelope](#) bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

6. To purchase a hard copy of the Bidding Documents in English, eligible bidders should:
- write to Procurement Service PS-DBM at PS Complex, RR Road, Cristobal Street, Paco, Manila 1107, Metro Manila, Philippines to request same
 - pay a non-refundable fee of Philippine Pesos Seventy-Five Thousand (Php 75,000.00) for each set of Bidding Documents required. Due to the extraordinary circumstances and consistent with the effort of the Philippine Government to curb the further spread of the contagion, payments may be made through cashier's check made payable to "PROCUREMENT SERVICE", cash payment over the counter on the Procurement Service Cashier, or online payment through the bank account details to be provided by PS-DBM upon receipt of written request.

Important notes:

- Due to the 72-hour standard wire transfer clearing process for online transfers, Bidders are strictly advised to ensure transfers are made at least three (3) days before the Deadline of Submission of Bids or no later than 10:00 hours on 10 July 2021.
 - Bidders who choose to transfer payments online shall ensure that the amount transferred shall be sufficient to cover the transfer fees of correspondent banks upon conversion of the original currency to Philippine Pesos.
 - Bidders shall send proof of payment to the official BAC e-mail on the same day of transfer.
 - For the avoidance of doubt, the non-refundable fee of PhP75,000 must be paid by a Bidder before submitting its bid, regardless whether the Bidder obtains a hard copy of the Bidding Document or not. However, if a Bidder requests for a hard copy, the PhP75,000 shall be paid upon the Bidder's request of the hard copy of the Bidding Document.
 - No fee shall be levied on a potential Bidder who downloads an electronic version of the documents but who subsequently does not request a hard copy and does not submit a bid.
7. Deliver your bid:
- to the address above (para 5):
 - **on or before the deadline: 10:00 hours (local time) on 14 July 2021.**
 - Together with a bid security in the amount as specified in the Bidding Documents.
8. Bids will be opened immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend and Observers who are physically present in the activity. In the event that the community quarantine continues to subsist and remains in effect on the date of the Opening of Bids, the Procurement Service shall limit the number of on-site attendees to a maximum of three (3) representatives per Bidder. The same activity shall be

available for online viewing through videoconferencing. Details of how to register for the video conference will be provided to Bidders in a subsequent bid bulletin.

9. Concurrently with the bidding for CP S-02, it is also intended to bid out the following package:

Package CP S-01 (under 52083: Malolos-Clark Railway Project, Tranche 1 [Loan 3796-PHI]): Building and Civil Engineering Works for approximately 1.2 km of Railway Viaduct Structure including elevated Station at Blumentritt.

10. The Bidding Documents for Packages CP S-01, and CP S-02 have been prepared separately but will nonetheless be bid out concurrently. Bidders may bid for a single package only or for both packages. In case the Bidder would wish to submit bids for more than one package, such bids should be submitted independently and not combined into a single bid. In accordance with ITB 14.6 and ITB 14.4, any discount offered by Bidders submitting bids for multiple bids and the methodology for the application of any discount shall be stated in the Letter of Bid included in its bids for each package. The Employer shall evaluate and compare bids on the basis for each package separately or for both packages combined in order to arrive at the least-cost combinations for the Employer, by taking into account such discounts offered by Bidders for award of both contracts.
