1. The **People's Republic of China** has received a loan from the Asian Development Bank towards the cost of **Anhui Chao Lake Environmental Rehabilitation Project** and it intends to apply part of the proceeds of this loan to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Hefei East New Town Construction Investment Co., Ltd.**, (the "Employer"), invites sealed bids from all eligible Bidders for **Sewerage Pipeline and Pumping Station Civil Works, Equipment Supply and Installation in Hefei Circular Economy Demonstration Park with Contract No.: H14-B-C01 in Feidong county, Anhui**. The scope of works is as follows: new construction of Weiqi Road, Weiliu Road, Weisan Road, Jingsan Road, Connecting line to dock, Weiwu Road and Xin Hema Road, etc sewerage pipeline, total 22460 meters. Construction of Jingsan Road and Weiwu Road pumping station with equipment supply and installation. Construction period of the above engineering is twelve (12) months.
3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - **Bidders qualifications:** Domestic Bidders shall have Grade II or above Municipal Engineering Construction General Contracting Certificate and Grade II or above Mechanical & Electrical Engineering Construction General Contracting Certificate, foreign Bidders shall have an equivalent certificate issued by their country of incorporation.
 - **Size of operation:** Minimum average annual turnover of CNY 312.93 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2014-2016).
 - **Contractual Experience:**

- Within the last five (5) years prior to bid submission deadline, participation as contractor, management contractor, or subcontractor; (i) shall have at least two (2) sewer network civil works contracts, and each with a wastewater pipeline value of at least CNY 90 million, meantime one (1) of above mentioned wastewater pipeline works contracts should be completed and normal operating; (ii) shall have two (2) capacity 3500 tons/day integrated pumping station equipment supply and installation contract experience. The contract content is similar to the proposed Works.
- Qualification criteria requirements for key equipment: (1) Offered integrated pumping station shall have ten (10) years or above production experience, in at least five (5) or more capacity 3500 tons/day integrated pumping station contractual experience and each successfully operating more than five (5) years; (ii) manufacturer of submerged waste water pump and integrated pumping station should be same.
- Cashflow Capacity: The Bidder shall demonstrate access to, or availability of, financial resources such as liquid assets, lines of credit, and other financial means, other than any contractual advance payments to meet:
 - the following cash-flow requirement of CNY31.29 million and
 - the overall cash flow requirements for this contract and its concurrent commitments.
- Financial Position: Submission of audited financial statements for the last three (3) years (2014-2016) to demonstrate the current soundness of the Bidders financial position and its prospective long term profitability. As a minimum, a Bidder's net worth calculated as the difference between total assets and total liabilities for each of the three years should be positive.

5. Interested eligible Bidders may obtain further information from website of Anhui Hefei Public Resources Trading Center at www.hfztb.cn and inspect the Bidding Documents on the website from 9:00 hours on 26 December 2017 to 17:30 hours on 24 January 2018.
6. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
7. The Bidder may log in to the website of Anhui Hefei Public Resources Trading Center (www.hfztb.cn) to download of the Bidding Documents free of charge from 26 December 2017 to 24 January 2018.

8. Bids must be delivered to the address below **on or before 25 January 2018 at 9:30 hours (Beijing time)**. Late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives who choose to attend in person at the address below **on 25 January 2018 at 9:30 hours**. All bids must be accompanied by a bid security as specified in the Bidding Documents.
