The People's Republic of China has received a loan from the Asian Development Bank (ADB) toward the cost of **Anhui Chao Lake Environmental Rehabilitation Project**, and it intends to apply part of the proceeds of this loan to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Feixi County Urban and Rural Construction Investment Co., Ltd.** (the "Employer"), invites sealed bids from all eligible Bidders for **Feixi County Environment Integrated Improvement for Rivers Flowing into Chao Lake Sub-project (Feixi County Yandian Town Ecological Demonstration Park Water Environment Comprehensive Rehabilitation) River Rehabilitation, Wetland and Sewerage Pipelines Construction** with Contract No.: H4-A-C03 in Feixi county, Anhui. The scope of works is as follows: river comprehensive rehabilitation, wetland works and sewerage pipeline construction. Details specified in drawings, bill of quantities and technical specifications. Construction period of the above engineering is eighteen (18) months.
3. **National Competitive Bidding** (NCB) will be conducted in accordance with ADB's Single-Stage: One Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Documents.
4. Interested eligible Bidders may obtain further information from website of Anhui Hefei Public Resources Trading Center at www.hfztb.cn and inspect the Bidding Documents on the website from 9:00 hours on 10 August 2018 until before 9:30 hours on 11 September 2018.
5. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.

6. Only eligible Bidders with the following key qualifications should participate in this bidding:
- Bidders qualifications: The domestic Bidders Shall have Grade I or above General Contracting Certificate of Water Conservancy and Hydropower construction and Grade I or above General Contracting Certificate of Municipal Public Engineering Construction issued by Ministry of Housing and urban-Rural Development, foreign Bidders shall have an equivalent certificate issued by their county of incorporation.
 - Size of operation: Minimum average annual turnover of CNY 259 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (Year 2015-2017).
 - Contractual Experience: Within the last five (5) years prior to bid submission deadline, participation as contractor, management contractor, or subcontractor, in at least one (1) river comprehensive rehabilitation civil works contracts (length of rivers should not less than 7km) with a value of at least CNY 30 million, one (1) wetland construction contract (wetland area should not less than two hundred and forty thousand square meter) with a value of at least CNY 37 million, and one (1) sewerage pipeline construction contract (among solid pipe wall structure compound plastic pipeline length shall not less than 4.7km) with a value of at least CNY 42 million. The contract or the corresponding (sub-) division of the contract to have been successfully or substantially completed prior to the bid submission deadline.
 - Cashflow Capacity: The Bidder shall demonstrate access to, or availability of, financial resources such as liquid assets, lines of credit, and other financial means, other than any contractual advance payments to meet: (i) the following cash-flow requirement of CNY25.90 million and (ii) the overall cash flow requirements for this contract and its concurrent commitments.
 - Financial Position: Submission of audited financial statements for the last three (3) years (Year 2015-2017) to demonstrate the current soundness of the Bidder's financial position and its prospective long-term profitability. As a minimum, a Bidder's net worth calculated as the difference between total assets and total liabilities for each of the three (3) years should be positive.

7. The Bidder may log in the website of Anhui Hefei Public Resources Trading Center at www.hfztb.cn to download the Bidding Documents free of charge from the date the Bidding Documents are issued from 10 August 2018 to 11 September 2018.
8. Bids must be delivered to the address below **on or before 11 September 2018 at 9:30 hours (Beijing time)**. Late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives who choose to attend in person at the address below **on 11 September 2018 at 9:30 hours**. All bids must be accompanied by a Bid Security as specified in the Bidding Documents.
9. The Employer and the Procurement Agent (para 12) will bear no liability for loss or late delivery of postal submission.
10. The bid invitation will be published in www.adb.org, www.chinabidding.com.cn and www.hfztb.cn at the same time.

11.
