The People's Republic of China has received a loan from the Asian Development Bank (ADB) toward the cost of **Anhui Chao Lake Environmental Rehabilitation Project**, and it intends to apply part of the proceeds of this financing to payments under the Contract for the **Water Environmental Integrated Management System Equipment Supply and Installation**. Bidding is open to Bidders from eligible source countries of ADB.

2. The **China Far East International Tendering Co. Ltd.** (CFEITC) (hereinafter referred to as "Procurement Agent"), authorized and on behalf of Chaohu (County) Urban Construction and Investment Co., Ltd invites sealed bids from eligible bidders for the following supply of goods:

All goods must be delivered on site within 180 days after the effective date of the contract.

3. **International competitive bidding** will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.

4. Interested eligible bidders may obtain further information from CFEITC and inspect the Bidding Documents at the address given below from March 20, 2019 to May 2, 2019, from 09:30 a.m. to 11:30 a.m., and 13:30 a.m. to 16:30 p.m. (weekday, except on weekend and holiday).

5. Only eligible bidders who can supply equipment with the following key qualifications should participate in this bidding:

- Successful completion as main supplier within the last five years (2014-2018) of at least two contracts each with a value of no less than CNY 8 million or equivalent in other currency with nature of integrated urban drainage information system experiences, and at least one of above contracts should be completed and successfully operated for more than one year.

The supply scope of above contracts or other contracts executed during the last five years (2014-2018) in combination should include water quality monitoring instruments and online automatic control system

- Bidder should have CMMI5 certificate.

Domestic Bidder should have information system integration certificate Grade II or above issued by Ministry of Industry and Information Technology of the People's Republic of China. Foreign bidders shall provide the equivalent documents from their respective jurisdictions.

- Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last 3 years (2015-2017) to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth over the past three years calculated as the difference between total assets and total liabilities should be positive.
- Minimum average annual turnover of CNY 90 million (or equivalent) calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 years (2015-2017) .
- Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is CNY11 million (or equivalent)..
