1. The People's Republic of China has received a loan from the Asian Development Bank toward the cost of **Xinjiang Integrated Urban Development Project** and it intends to apply part of the proceeds of this loan to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **MINMETALS International Tendering Co., Ltd.** (as the "Procurement Agent"), authorized by **Karamay City Infrastructure Improvement and Environmental Improvement ADB Project Management Office** (the "Employer"), invites sealed bids from all eligible Bidders for the construction of KL-C02: Kelamayi-Wetland construction and treated wastewater storage recycling project (area 9.93 km²). The completion period is 470 days from contract signing.
3. **National competitive bidding** will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - A positive net worth; Bidders must submit their audited Balance Sheets for the last three (3) years to demonstrate the current soundness of their financial position.
 - An average annual turnover of at least CNY 280 million in the last three (3) years.
 - Demonstrate access to or availability of liquid assets, lines of credit, or other financial resources other than any contractual advance payments of at least CNY 24 million.
 - Experience under contracts in the role of contractor, subcontractor, or management contractor for at least the last five (5) years prior to the bid submission deadline (excluding investment projects). Certification materials include the award notice contract and acceptance report. The Bidder should have municipal public engineering general contracting Level-1 and above, water conservancy and hydropower project construction general contracting Level-2 and above.
 - Participation as contractor, management contractor, or subcontractor, in at least two (2) municipal public facilities municipal engineering or water conservancy projects (excluding investment projects) contracts within the last five (5) years prior to the bid submission deadline, each with a value of at least 80 million that have been successfully

and substantially completed and that are similar to the proposed Works. The similarity shall be based on the physical size, complexity, methods/technology or other characteristics as described in Section VI, Employer's Requirements. Certification materials include the award notice contract and acceptance report.

The qualification criteria are more completely described in the Bidding Document.

5. Interested eligible Bidders may obtain further information from MINMETALS International Tendering Co., Ltd. (as the Procurement Agent) and inspect the Bidding Documents at the address given below between 8:30 to 11:30 hours in the morning and 13:00 to 16:00 hours (Beijing Time), or between 10:00 to 13:00 hours and 16:00 to 19:00 hours (Urumqi Time) (except during Saturdays, Sundays, and holidays).
6. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
7. A complete set of Bidding Documents in Chinese may be purchased by interested Bidders on the submission of a written application to the address below and upon payment of a nonrefundable fee CNY1500. The method of payment is in cash. At the request of the Bidder, the Bidding Documents may be sent by courier for an additional amount of CNY100 per set.
8. Bids must be delivered to the address below at or before 11:00 hours on 7 March 2019. Late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives who choose to attend in person at the address below at 11:00 hours (Beijing time) on 7 March 2019. All bids must be accompanied by a bid security with amount specified in the Bidding Documents.
