1. The People's Republic of China has received the loan from the Asian Development Bank toward the cost of **Huainan Urban Water Systems Integrated Rehabilitation Project** and it intends to apply part of the proceeds of this loan to payments under the Contract named above. The Bidding is open to Bidders from eligible source countries of the ADB.
2. The **China International Tendering Co., Ltd** (hereinafter referred to as "Procurement Agent"), authorized by **Maoji District Key Project Construction and Management Bureau** (hereinafter referred to as "Employer") invites sealed bids from all eligible Bidders for **Installation of sewers in Maoji District (41.1km)**. The construction period is 18 months.
3. **National competitive bidding** will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - Minimum average annual turnover of CNY 220 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2015-2017).
 - Participation as contractor, management contractor, or subcontractor, in at least two (2) contracts of similar sewage pipe network construction within the last five (5) years (2013 until bid submission), each with a value of at least CNY 70 million that have been successfully and substantially completed and that are similar to the proposed Works.
 - The Bidder shall demonstrate access to, or availability of, financial resources such as liquid assets, lines of credit, and other financial means, other than any contractual advance payments to meet: (i) the following cash-flow requirement of CNY 22 million and (ii) the overall cash flow requirements for this contract and its concurrent commitments.
 - The domestic Bidders and the domestic Bidders who associate with foreign Bidders as Joint Ventures should have Grade I or above General Contractor Qualification for Municipal Public Works (issued by Construction Administrative Department).

Detailed qualification requirements are found in Section 3 of the Bidding Document.

5. Interested eligible Bidders may obtain further information from Procurement Agent (email address and contact person as shown below) and inspect the Bidding Documents at the address given below between 9:00-11:30 hours in the morning and 13:30-16:00 hours in the afternoon (Beijing time) of each working day.
6. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
7. A complete set of Bidding Documents in Chinese may be purchased by interested Bidders on the submission of a written application to the ITC's address below and upon payment of a nonrefundable fee of CNY 1,200. The method of payment will be cash, check or direct deposit (Bank Account Name: China International Tendering Co., Ltd; Bank: Head Office of Bank of China; Bank Account No.: 778350010653). The Bidding Documents will be sent by EMS if required by the Bidder, and extra CNY 50 should be paid for one set of Bidding Documents.
8. Bids must be delivered to the address below **at or before 9:00 hours (Beijing time) on 2 November 2018**. Late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives who choose to attend in person at the address below **at 9:00 hours (Beijing time) on 2 November 2018**. All bids must be accompanied by a bid security as specified in the Bidding Documents.
