1. The People's Republic of China has received financing from the Asian Development Bank toward the cost of **Guangdong Chaonan Water Resources Development and Protection Demonstration Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The **Chaonan Water Supply Company** ("the Purchaser") invites sealed bids from eligible Bidders for **Pipe and Equipment Supply of Main Pipeline Project of Xiaxin Line, Sigao Line and Heyang Line (G5)**.
3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in the bidding:
  - From 1 January 2014 to the bid submission deadline, the Bidder, as leading goods supplier, should have successfully or substantially completed at least two (2) goods supply contracts for water supply pipe material and equipment. Each contract should be not less than RMB 25 million or equivalent (not including the expense of civil works and equipment installation);
  - The goods offered have been in production for at least three (3) years and been in operation for a minimum of two (2) years.

Additional details are provided in the Bidding Documents.
