1. The People's Republic of China has received a loan from the Asian Development Bank (ADB) toward the cost of **Yunnan Chuxiong Urban Environment Improvement Project** and it intends to apply part of the proceeds of this loan to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. Instrimpex International Tendering Co., Ltd (CNIITC, the Procurement Agent), authorized by and on behalf of Chuxiong Development and Investment Company Limited ("the Purchaser"), now invites sealed bids from eligible bidders for the goods and related services to be procured as briefly described as follows:

Green Bus (Electric Bus)

- include 110 vehicles of electric bus,
- 15 units of 150KW double-gun dc charging point and related services,
- The related services include inland transportation, insurance of the equipment to the project location and training to the Purchaser

Delivery time: within 90 days after contract signing

3. **International competitive bidding (ICB)** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) (1S1E) procedure and is open to all bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- **Contractual Experience**

Successful completion as main supplier within the last 3 years (from 2016 to the bid submission deadline), of at least 2 similar contracts, each valued not less than CNY 20 million or equivalent in other currency, with the contract scope of electric bus.

- **Technical Experience**

The Electric Bus Manufacturer (电动车制造商) has sold an average annual minimum of 17000 sets of coach (including bus and Highway Passenger Cars) (客车 (含公交车和公

路客运车)), which includes at least an average annual sales of 2300 sets of electric bus (纯电动公交车) for the last three years (2016-2018)

- **Production Capacity**

The Manufacturer of electric bus should have at least 5 years in manufacturing electric bus.

- **Historical Financial Performance**

Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last 3 years (2016-2018) to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last 3 years (2016-2018) calculated as the difference between total assets and total liabilities should be positive.

- **Size of Operation (Average Annual Turnover)**

Minimum average annual turnover of CNY 100 million, or equivalent in other currency calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 years (2016-2018).

- **Cash Flow Capacity**

Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement, which is CNY 15 million, or equivalent in other currency.
