The People's Republic of China has received a loan from the Asian Development Bank (ADB) toward the cost of **Low-Carbon District Heating Project in Hohhot in Inner Mongolia Autonomous Region**, and it intends to apply part of the proceeds of this financing to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **China Far East International Tendering Company (CFEITC)** (hereinafter referred to as "Procurement Agent"), authorized and on behalf of the Hohhot City Development, Investment, and Operation Company and Hohhot Chengfa Heating Company invites sealed bids from eligible bidders for the following supply of goods:

All goods must be delivered on site within 450 days after the effective date of the contract.

3. **International Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.

4. Interested eligible Bidders may obtain further information from CFEITC and inspect the Bidding Documents at the address given below from 16 January 2018 to 6 March 2018 from

9:30 to 11:30 hours in the morning and 13:30 to 16:30 hours in the afternoon (weekdays, except on weekends and holidays).

5. Only eligible Bidders who can supply equipment with the following key qualifications should participate in this bidding:

- Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last three (3) years (2014-2016) to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.
- Minimum average annual turnover of USD 13.5 million (or equivalent) calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years (2014-2016).
- Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is USD 4.15 million (or equivalent).
- Successful completion as main supplier within the last five (5) years prior to the bid submission date, of at least three (3) contracts each valued at USD 6.7 million (or equivalent) with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply). At least one of the above contracts for supply of equipment for district heating.
- Bidders within the Purchaser's country should have the Import and Export enterprise qualification, if the Bidder offer goods from outside the Purchaser's country.
- Bidders shall have valid ISO 9001 certificate or its equivalent.
