The People's Republic of China has received a loan from the Asian Development Bank toward the cost of **Jiangxi Pingxiang Integrated Rural-Urban Infrastructure Development Project** and it intends to apply part of the proceeds of this loan to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **CITIC International Tendering Co., Ltd.** (hereinafter referred to as "Procurement Agent"), authorized by and on behalf of **Luxi County City Construction Investment Development Co., Ltd.** (the "Employer") invites sealed bids from all eligible Bidders for the **Tankou and Xinhua Rivers Dam Supply and Installation** with the following details:

3. **National competitive bidding** will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Size of Operation	The Bidder's average annual turnover over the latest three (3) years (2015-2017) shall be not less than RMB 12 million.
Contractual Experience	At least two (2) goods (hydraulic gate) supply contracts successfully completed as supplier within the last three (3) years (2015-2017) each valued at not less than RMB 4 million with nature, and complexity similar to the scope of supply. Related documentary evidences shall be provided.

Technical Experience	Goods offered have been in production for at least five (5) years and a minimum of two (2) of similar capacity have been sold and have been in operation satisfactorily for at least three (3) years. Related documentary evidences shall be provided.
Production Capacity	Minimum supply and/or production capacity required to assure that the Bidder is capable of supplying the type, size, and quantity of the Goods required.
Financial Situation	Soundness of the Bidder's financial position showing long-term profitability demonstrated through audited annual financial statements (balance sheet, income statement) for the last three years (2015-2017). As a minimum, a Bidder's net worth calculated as the difference between total assets and total liabilities for each of the three (3) years should be positive.
Cash Flow Capacity	Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet any possible cash flow requirement which may arise during the execution of the contract shall not be less than: RMB 1 million.
Qualification Requirements	<ol style="list-style-type: none"> 1. Bidders shall be legal persons of independent enterprises; 2. Soundness of the Bidder's financial position showing long-term profitability demonstrated through audited annual financial statements (balance sheet, income statement) for the last three years (2015-2017). 3. Bidders shall have safe production license; 4. Bidders shall have level III (or above) qualification for special contract of hydraulic metal structure fabrication and installation; 5. Bidders shall have medium-sized (and below) sluice production license issued by General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China, and medium-sized (and above) hydraulic hoist use permit issued by Ministry of Water Resources; 6. Bidders shall have effective ISO quality management system certificate or equivalent quality management system certificate; 7. Bidders shall have relevant certification with color copies for technical experience of goods in tendering documents; 8. Bidders shall have relevant certification with color copies for similar contractual experience; 9. In case of goods manufactured by others, Bidders shall provide the original letter of authorization issued by the manufacturer to prove they have been formally authorized by the goods manufacturer.

The qualification criteria are more completely described in the Bidding Document.

6. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
