1. The **People's Republic of China** has received a loan from the Asian Development Bank toward the cost of **Jiangxi Pingxiang Integrated Rural-Urban Infrastructure Development Project**, and it intends to apply part of the proceeds of this loan to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **CITIC International Tendering Co., Ltd.** (hereinafter referred to as "Tendering Agent"), authorized by Luxi County City Construction Investment Co., Ltd. (hereinafter referred to as "Employer"), invites sealed bid from all eligible Bidders for the **Yuan River Rehabilitation in Luxi County**.

The Rehabilitation Works is for downstream section (skate mark: YH3+850~YH7+600) divided by Yuan River newly-built National Highway 320 Bridge. The total length of river treatment is about 3.75km.

The construction period is 18 months.

3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
  - All pending litigation shall in total not represent more than 50 percent of the Bidder's net worth and all unresolved litigation shall be calculated according to the Bidder's failure.
  - Submission of audited balance sheets for the last three (3) years (2014-2016) to demonstrate the current soundness of the Bidder's financial position and its prospective long-term profitability. As a minimum, a Bidder's net worth for the last three (3) years

(2014-2016) calculated as the difference between total assets and total liabilities should be positive.

- Experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least five (5) years prior to the bid submission deadline (it shall be subject to the registration date of business license).
- Average Annual Construction Turnover (2014-2016) should be at least CNY 79 million.
- Minimum cash flow should be CNY 7.9 million including cash flow for its concurrent contract commitment.
- Participation as contractor, management contractor, or subcontractor, in at least two (2) contracts for river comprehensive treatment works (including dredging, revetment, flood protection dyke, gates and wetland filling works etc.) within the last five (5) years (2012-2016), each with a value of at least CNY 38 million, that have been successfully and substantially completed and that are similar to the proposed Works, in which the contracts shall include construction Works of landscape architecture and landscaping.
- Documentary evidences (copies of: 1. Notification of award of contract; 2. Construction contract; 3. Completion acceptance certificate or other related documents) stamped with common seal of Bidder shall be furnished in its bid; the originals shall be provided for further checking.
- For domestic Bidders and the domestic Bidders who associate with foreign Bidders as Joint Ventures shall have a Grade I or above Qualification Certificate for General contracting of Water and Hydro-power engineering projects issued by Ministry of Housing and Urban-Rural Development of PRC at the same time be equipped with Grade I or above Qualification Certificate for River and Lake Treatment engineering. Foreign bidders shall provide the equivalent documents from their respective jurisdictions.
- The Bidder shall have a valid Work Safety Certificate. Note: The original certificates (or notarized counterparts of the certificates) shall be presented for verification at the time of bid opening.

The qualification criteria are more completely described in the Bidding Document.

5. Interested eligible Bidders may obtain further information from the Tendering Agent whose contact information is listed as below (see para 7) and inspect the Bidding Documents from 17 November 2017 to 17 December 2017 from 9:00 to 11:30 hours in the morning and 14:30 to 17:00 hours in the afternoon.
6. The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
7. A complete set of Bidding Documents can be purchased by interested Bidder upon submission of a written application to the Tendering Agent (see address below) and after paying a non-refundable fee of CNY 1500. Payment methods: cash, cheque or directly
