The People's Republic of China has received a loan from the Asian Development Bank (ADB) toward the cost of **Henan Sustainable Livestock Farming and Product Safety Demonstration Project**, and it intends to apply part of the proceeds of this loan to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **China Far East International Tendering Co., Ltd. (hereinafter referred to as "Procurement Agent")**, authorized by **Henan Animal Husbandry Bureau (hereinafter referred to as "Purchaser")**, invites sealed bids from all eligible Bidders for the six (6) sets of Laboratory Equipment (for details of technology requirements, please see the Bidding Document).

The delivery period is three (3) months after contract signature.

3. **International competitive bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:
- Minimum average annual turnover of CNY 35 million (or equivalent) calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years (2015–2017)
 - Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is CNY 3 million (or equivalent)
 - Successful completion as main supplier within the last three (3) years prior to the bid submission date, of at least three (3) contracts valued at CNY13,000,000.00 (or equivalent) contract with nature, and complexity similar to the scope of supply described in Section 6
 - The Bidder shall demonstrate that Liquid chromatography - tandem quadruple mass spectrometer offered have:
 - been in production for at least eight (8) years
 - sold a minimum of 20 units over the last three (3) years
 - been in operation for a minimum of two (2) years
 - the best models of sensitivity, repeatability, scanning rate, etc. for the series of products produced by the manufacturer
