

## Invitation for Bids

- The People's Republic of China has received a loan from the Asian Development Bank (ADB) toward the cost of Guangxi Regional Cooperation and Integration Promotion Investment Program (Tranche 2), and it intends to apply part of the proceeds of this financing to payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The Guilin University of Aerospace Technology (the "Employer"), invites sealed bids from eligible bidders for China ASEAN SME Synergy Innovation Development Project (Aeronautic and Aerospace Industry Practice Base Building). The contract is construction of two Aeronautic and Aerospace Industry Practice Base Buildings located at No.2 Jinji Road and in the Guilin University of Aerospace Technology with the following details:

#### No.1 of Industry Practice Base Building for new campus extension:

- Grade II of building engineering, frame structure, building seismic class VI;
- The floor area is 24135.91m<sup>2</sup> (ground floor area: 19833.19m<sup>2</sup>, semi-basement area is 4302.72m<sup>2</sup>, first floor area is 3694.21m<sup>2</sup>)
- There are 6 floors, but the 6<sup>th</sup> floor only covers half of the building.
- The Building Height is 23.65m

#### No.2 of Industry Practice Base Building for new campus extension:

- Grade II of building engineering, frame structure, building seismic class VI;
- The floor area is 20804.36m<sup>2</sup> (no basement area; first floor area is 4271.18m<sup>2</sup>);
- There are 6 floors;
- The Building Height is 23.65m

The scheduled construction period of this contract shall be 388 days from starting date of the project construction.

 National competitive bidding will be conducted in accordance with ADB's <u>Single-Stage:</u> <u>One-Envelope</u> procedure and is open to all bidders from eligible countries as described in the Bidding Document.

Interested eligible Bidders may obtain further information from Procurement Agent's office (Instrimpex International Tendering Company) and inspect the Bidding Documents at the address given below from 8:30 to 11:00 hours in the morning and 13:30 to 16:30 hours during weekdays (except on weekends and holidays).
- The attention of prospective Bidders is drawn to the eligibility and conflict of interest provisions under ITB 4 of the Bidding Documents. All Bidders found to have a conflict of interest shall be disqualified.
- 6. Only eligible Bidders with the following key qualifications should participate in this bidding:
  - Minimum average annual turnover of CNY245 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2015-2017).
  - The Bidder shall demonstrate access to, or availability of, financial resources such as liquid assets, lines of credit, and other financial means, other than any contractual advance payments to meet: (i) the following cash-flow requirement of CNY 25 million and (ii) the overall cash flow requirements for this contract and its concurrent commitments.
  - Experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least six (6) years (2013 the bid submission deadline).
  - Participation as contractor, management contractor, or subcontractor, in at least two
    (2) contracts within the last six (6) years (2013 the bid submission deadline), each
    with a value of at least CNY 80 million, and the individual building area were not less
    than 20,000m² for housing construction which have been successfully and
    substantially completed and that are similar to the proposed Works. The similarity
    shall be based on the physical size, complexity, methods/technology or other
    characteristics as the contract.
  - The domestic Bidders and the domestic Bidders who associate with foreign Bidders as Joint Ventures should have the Certificate of Construction Engineering (Grade II or above) of General Contractors issued by the Ministry of Housing and Urban-Rural Development of the People's Republic of China (MOHURD); the safety production license should be provided; the safety production license should be provided. Foreign Bidders shall have an equivalent certificate issued by their country of incorporation.

All bids must be accompanied by a bid security corresponding with the requirement of Bidding Documents.
