1. The Democratic Socialist Republic of Sri Lanka has received financing from the Asian Development Bank (ADB) toward the cost of **Supporting Electricity Supply Reliability Improvement Project**. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of ADB.
2. The **Ceylon Electricity Board** (CEB), (“the Purchaser”), now invites sealed bids from eligible bidders for the **Supply and Delivery of Material for Supporting Electricity Supply Reliability Improvement Project – Package 5 Lot 4**.

3. **International Competitive Bidding** (ICB) will be conducted in accordance with ADB’s [Single Stage: One Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible bidders with the following key qualifications should participate in this bidding:

Successful completion as main supplier within the last three (3) years, of at least three (3) Contracts each valued at least USD 100,000.00 with the nature and complexity similar to the scope.

No liability will be accepted for loss or late delivery.
