1. The Government of Democratic Socialist Republic of Sri Lanka has applied for financing from the Asian Development Bank toward the cost of **Northern Province Sustainable Fisheries Development Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Chairman of the Cabinet Appointed Procurement Committee on behalf of the Ministry of Fisheries & Aquatic Resources Development and Rural Economic Affairs** (“the Employer”) invites sealed bids from eligible Bidders for the ***Construction and completion of Point Pedro Fishery Harbor and Munai Landing Site in Jaffna District***. The contract will involve with construction of a Primary Breakwater of 880 meters long (sea bed level 10m below Mean Sea Level), Secondary Breakwater of 425meters long, Quay walls and Jetties (sea bed level 8m and 9m below Mean Sea Level), Dredging of approximately 100,000 cubic meters including underwater controlled rock blasting and/ or chemical blasting, and Construction of array of Landside Facilities and Infrastructure of the Proposed Fishery Harbor in Point Pedro. The Munai Landing site which is about a further 1km to the East of Point Pedro is also being developed under the contract. The contract period is 48 months from the contract signing date.

3. **Open competitive bidding - International** will be conducted in accordance with ADB’s [Single-Stage: Two-Envelope](#) bidding procedure and is open to all to bidders from eligible countries as described in the Bidding Document.

4. Only eligible bidders with the following key qualifications should participate in this bidding:

- a) Minimum average annual construction turnover of USD 26.5 Million (Twenty-Six and a Half Million USD) calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
- b) Construction of Breakwater of length not less than 500m and in sea water depth of not less than 10m in 24 months
- c) Construction of marine structures on piles of more than 200m length, at water depths of 8m or deeper, in 12 months
- d) Construction of gravity type quay wall structures of more than 250m length at water depth of 5m or deeper, in 10 months

- e) Construction of land side facilities of at least one fisheries harbor of similar nature and size, or at least two building schemes having cumulative floor area of more than 6,000 sq. m. in each scheme
- f) Dredging in 5m depth or more exceeding a quantity of 100,000 cubic meters. Shall have under sea water blasting experience of more than 27,000 cum, by control blasting using explosives and/or chemical blasting

9. Ministry of Fisheries & Aquatic Resources Development and Rural Economic Affairs will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation, attending pre-bid meeting, site visits and delivery of bids.
