1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of **Strengthening Technical and Vocational Education and Training Project** (TVET). Part of this financing will be used for payments under the contract named above. No nationality restrictions apply other than restrictions arising from ITB 4.7.

2. The Project Administration Group (PAG) of the **Ministry of Labour, Migration and Employment** (“the Employer”) invites sealed bids from eligible Bidders for the **Civil works for minor rehabilitation of targeted lyceums (TVET Auto Transport and TVET Tourism and Service lyceums in Dushanbe, TVET lyceums in Shahrinav, Tojikobod, and Istaravshan and TVET Agricultural lyceum in Shahrison)** (“the Works”). The works shall be completed within four (4) months from Contract Signing Date.

3. **National Competitive Bidding** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all eligible Bidders without nationality restrictions.

4. Only eligible Bidders with the following key qualifications may participate in this bidding:

- Minimum average annual construction turnover of Six Million Five Hundred Thousand Tajik Somoni (TJS 6,500,000.00) or equivalent calculated as total certified payments received for contracts in progress or completed, within the last three (3) years;
- Availability of financial resources of Two Million Four Hundred Thousand Tajik Somoni (TJS2,400,000.0)
- Participation in at least one (1) contract that has been successfully or is substantially completed within the last five (5) years and that is similar to the proposed civil works where the value of the Bidder’s participation exceeds Two Million Six Hundred Thousand Tajik Somoni (TJS 2,600,000.00) or equivalent;

The qualification criteria are more completely described in the Bidding Documents.
