1. The Government of the Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of “**Building Climate Resilience in the Pyanj River Basin Project**”. Part of this financing will be used for payments under the contract named above. Bidding is open to all bidders from eligible source countries of Asian Development Bank.

2. The State Unitary Enterprise “Khochagii Manziliyu Kommunalii” (KMK) of the Republic of Tajikistan (“the Employer”) invites sealed bids from eligible Bidders for the completion of works on **NCB-CW-05/P5: Climate-proof Water Supply System in the Pyanj District (Namuna Water Supply Subproject)** (“The works”)

3. **National Competitive bidding** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding for **Package No. NCB/CW-05/P5: Climate-proof Water Supply System in the Pyanj district (Namuna Water Supply Subproject)**

- a) Construction Experience in:
 - Laying of Pipes 10 km
 - Bore-well
- b) Financial requirements:
 - As a minimum, the Bidder’s net worth for the last year calculated as the difference between total assets and total liabilities should be positive.
- c) Minimum average annual construction turnover of USD 1,218,000 calculated as total certified payments received for contracts in progress or completed, within the last 3 years.
- d) The Bidder must have successfully or substantially completed at least two (2) similar contracts where the value of each contract exceeds USD 730,000 in the last 5 years
