



## Invitation for Bids

1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of **Strengthening Technical and Vocational Education and Training Project** (TVET). Part of this financing will be used for payments under the contract named above. No nationality restrictions apply other than restriction arising from ITB 4.7.

2. The **Project Administration Group (PAG) of the Ministry of Labor, Migration and Employment** (“the Purchaser”) invites sealed bids from eligible Bidders for ***Furniture for classrooms, workshops, kitchen and dormitories of lyceums and dormitories - Dushanbe and District of Republican Subordination*** (“the Goods”). Delivery period is within 150 days from the Contract Signing Date.

3. **National Competitive Bidding** will be conducted in accordance with ADB’s Single-Stage: One-Envelope bidding procedure and is open to all eligible Bidders without nationality restrictions.

4. Only eligible Bidders with the following key qualifications may participate in this bidding:

- Minimum average annual turnover of **One Million One Hundred Sixty-Eight Thousand US Dollars** (USD 1,168,000.00) calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 (three) years.
- Successful completion as main supplier within the last 5 (five) years, of at least 2 (two) contracts each valued at **Four Hundred Sixty-Seven Thousand US Dollars** (USD 467,000.0) with nature, and complexity similar to the proposed scope of supply.

***The qualification criteria are more completely described in the Bidding Documents.***
