1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of **Strengthening Technical and Vocational Education and Training Project** (TVET). Part of this financing will be used for payments under the contract named above. No nationality restrictions apply other than restriction arising from ITB 4.7.

2. The **Project Administration Group (PAG) of the Ministry of Labor, Migration and Employment** (“the Purchaser”) invites sealed bids from eligible Bidders for the procurement of **Teaching Equipment for Additional Lyceums** (“the Goods”). Delivery period is within 120 days from the Contract Signing Date.

3. **National Competitive Bidding** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all eligible Bidders without nationality restrictions.

4. Only eligible Bidders with the following key qualifications may participate in this bidding:

- Minimum average annual turnover of One Million Nine Hundred Forty Thousand US Dollars (USD 1,940,000.00) calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.
- Successful completion as main supplier within the last five (5) years, of at least two (2) contracts each valued at Seven Hundred Seventy-Six Thousand US Dollars (USD 776,000.00) with nature, and complexity similar to the proposed scope of supply of goods.

The qualification criteria are more completely described in the Bidding Documents.
