1. The Government of the Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of “**Water Resources Management in Pyanj River Basin Project**”. Part of this financing will be used for payments under the contract named above. Bidding is open to all bidders from eligible source countries of ADB.

2. The **Agency for Land Reclamation and Irrigation** of the Republic of Tajikistan (“the Employer”) invites sealed bids from eligible Bidders for the completion of ***NCB-W-02: Workshop at Vose district for Pump Stations including civil works and supply of equipment*** (“the works”).

3. **National Competitive Bidding** will be conducted in accordance with ADB’s [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Documents.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

a) Construction Experience in:

- rehabilitation of buildings or pump stations
- supply of pumps or pumping equipment

b) As a minimum, the Bidder’s net worth for the last year calculated as the difference between total assets and total liabilities should be positive.

c) Minimum average annual construction turnover of USD 540,000 calculated as total certified payments received for contracts in progress or completed, within the last 3 years.

d) The Bidder must have successfully or substantially completed at least two (2) similar contracts where the value of each contract exceeds USD 220,000 in the last 3 years
