The Republic of Uzbekistan has applied for financing from the Asian Development Bank (ADB) toward the cost of **Tashkent Province Sewerage Improvement Project** and intends to apply part of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. The **ADB Project Coordination Unit (PCU) of O'zsuvta'minot JSC on behalf of the Toshkent Suv Ta'minoti LLC** ("the Employer") invites sealed bids from eligible Bidders for the **design, supply and installation of (i) Lot 1: Rehabilitation of WWTP with the capacity of 60,000 m³/day in Bekabad city, (ii) Lot 2: Rehabilitation of WWTP with the capacity of 100,000 m³/day in Almalyk city and (iii) Lot 3: Rehabilitation of WWTP with the capacity of 100,000 m³/day in Angren city** ("the Facilities"). Bidders are allowed to bid for a lot or any combination of lots.

3. **Open competitive bidding (international advertisement)** will be conducted in accordance with ADB's [Single-Stage: Two-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Average Annual Turnover

- Minimum average annual turnover of:

For Lot 1 – US\$11.90 million

For Lot 2 – US\$15.40 million

For Lot 3 – US\$14.40 million

calculated as total certified payments received for contracts in progress or completed, within the last 5 (five) years (2016-2020)

Financial Resources

- Financial resources, less its financial obligations for its current contract commitments, meet or exceed the total requirement for subject contract of:

For Lot 1 – US\$1.5 million

For Lot 2 – US\$1.9 million

For Lot 3 – US\$1.8 million

Contracts of Similar Size and Nature

- Participation as a contractor, Joint Venture partner, or Subcontractor, in at least two (2) contracts that has been successfully or substantially completed within the last ten (10) years and that is similar to the proposed contract, where the value of the Bidder's participation exceeds:

For Lot 1 – US\$8.9 million

For Lot 2 – US\$11.8 million

For Lot 3 – US\$10.7 million

The similarity of the Bidder's participation shall be based on process of WWTP, hydraulic profile, technology used, and others stipulated in Section 6 (Employer's Requirements).

The qualification criteria are more completely described in the Bidding Document.
