1. The **Social Republic of Vietnam** has received financing from the Asian Development Bank (ADB) toward the cost of the **Low Carbon Agricultural Support Project (LCASP)**, and intends to apply part of the proceeds toward payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The **Central Project Management Unit (CPMU) of LCASP** invites sealed bids from eligible Bidders for **Package 14: Livestock environmental monitoring and biogas database management equipment**. The contract consists of three (3) lots, as follows:
 - Lot 1: Equipment for supporting biogas database management
 - Lot 2: Provincial livestock environmental monitoring equipment
 - Lot 3: Comprehensive livestock environmental monitoring equipment for central agencies
3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to Bidders from all countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - Average annual turnover defined as the total payments received by the Bidder for contracts completed or under execution over the last three (3) years of: VND 6 billion for Lot 1; VND 15 billion for Lot 2; VND 16 billion for Lot 3. In the case of Joint Venture, all partners combined must meet the requirement, while one partner must meet 40% of the requirement and each partner must meet 25% of the requirement.
 - The Bidder must demonstrate access to, or availability of, liquid assets, lines of credit, or other financial resources, net of current commitments to meet the financial resources requirement of VND 1 billion for Lot 1; VND 2.2 billion for Lot 2; and VND 2.5 billion for Lot 3 for the subject contract.
 - Participation in at least two (2) contracts that have been successfully completed within the last three (3) years, and that are similar to the proposed goods, where the

value of the Bidder's participation exceeds: VND 2.5 billion for Lot 1; VND 6.1 billion for Lot 2; and VND 7.2 billion for Lot 3.

The qualification criteria are more completely described in the Bidding Document

5. Interested eligible Bidders may obtain further information from Mr. Nguyen, The Hinh director of Central Project Management Unit of LCASP and inspect the Bidding Documents during office hours (Mondays to Fridays, from 8:00 to 17:00 hours) at the address given below.
6. A complete set of Bidding Documents in Vietnamese may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of VND 2,000,000 (two million Vietnamese dong). The method of payment will be in cash or bank transferring (Bank account: 1507201061135 at Agribank – Cau Giay branch, please state clearly content of transferring: payment for Bidding Document of Package 14). The document may be sent through a courier for an additional cost of VND 50,000. No liability will be accepted for loss or late delivery.
7. Bids must be delivered to the address below **on or before 9:00 hours, 14 August 2107** together with a Bid Security as described in the Bidding Document. Late bids will be rejected. Bids will be opened immediately in the presence of the Bidders' representatives who choose to attend at the address below **at 9:00 hours on 14 August 2107**.
