1. The Socialist Republic of Vietnam has received financing from the Asian Development Bank toward the cost of the **Low Carbon Agricultural Support Project** (LCASP), and intends to apply part of the proceeds toward payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Central Project Management Unit** (CPMU) of LCASP invites sealed bids from eligible Bidders for “Package 36: supply of biogas generator system for demonstration of Binh Dinh, Ha Tinh, Lao Cai, Soc Trang and Tien Giang province. The contract consists of four (4) lots wherein Bidders are allowed to bid for any single lot or any combination of lots, as follows:

Lot 1: Binh Dinh.

Lot 3: Lao Cai.

Lot 4: Soc Trang.

Lot 5: Tien Giang.

3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB’s [Single-Stage One-Envelope](#) procedure and is open to all Bidders from eligible countries as described in the Bidding Document

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- Average annual turnover defined as the total payments received by the Bidder for contracts completed or under execution over the last three (3) years of: Lot 1: Binh Dinh: VND 3.0 billion; Lot 3: Lao Cai: VND 6.0 billion; Lot 4: Soc Trang: VND 1.6 billion; Lot 5: Tien Giang: VND 4.0 billion.
- The Bidder must demonstrate access to, or availability of, liquid assets, lines of credit, or other financial resources, net of current commitments to meet the financial resources requirement of Lot 1: Binh Dinh is VND 450 million, Lot 3: Lao Cai is VND 900 million, Lot 4: Soc Trang is VND 240 million; Lot 5: Tien Giang is VND 600 million for the subject contract.
- Participation in at least three (3) contracts that have been successfully completed within the last three (3) years, and that are similar to the proposed goods, where the value of

the Bidder's participation exceeds: Lot 1: Binh Dinh: VND 1.2 billion; Lot 3: Lao Cai: VND 2.4 billion; Lot 4: Soc Trang: VND 640 million; Lot 5: Tien Giang: VND 1.6 billion;

The qualification criteria are more completely described in the Bidding Document.

5. Interested eligible Bidders may obtain further information from Mr. Nguyen, The Hinh director of Central Project Management Unit of LCASP and inspect the Bidding Documents during office hours (Monday to Friday, from 8:00 A.M. to 5:00 P.M.) at the address given below.

6. A complete set of Bidding Documents in Vietnamese may be purchased by interested eligible Bidders upon submission of a written application to the address below and upon payment of a nonrefundable fee of VND 2,000,000 (two million Vietnamese dong). The method of payment will be in cash or bank transferring (Bank account: 1507201061135 at Agribank – Cau Giay branch, please state clearly content of transferring: payment for Bidding Documents of package 36). The document may be sent through a courier for an additional cost of VND 50,000. No liability will be accepted for loss or late delivery.

7. Bids must be delivered to the address below **on or before 9:00 A.M. on 11 September 2017**. Together with a Bid Security as described in the Bidding Document. Late bids will be rejected. Bids will be opened immediately in the presence of the Bidders' representatives who choose to attend at the address below at 9:00 A.M. on 11 September 2017.
