1. The Socialist Republic of Vietnam has received financing from the Asian Development Bank (hereinafter called "ADB") toward the cost of **Greater Mekong Sub-region Corridor Town Development Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Tay Ninh Province Economic Zone Authority through Tay Ninh Project Management Unit** ("the Employer") invites e-bids from eligible Bidders for the **package CW-11: An Thanh – Phuoc Chi Road Improvement** ("the Works").

Description of Work: Construction of An Thanh – Phuoc Chi Road in Ben Cau and Trang Bang Districts, Tay Ninh province, Vietnam

The Civil work includes main components:

- Road construction: Total of Length is 14.253,36m
- Bridge construction: Reinforced concrete bridge replaces existing bridge, Length of bridge is 15,8m, reinforced concrete piles with dimension 40x40cm
- Drainage system:
 - Longitudinal drainage: making a longitudinal trench system by reinforced concrete with the lid along both sides of the sidewalk for the sections passing through populated areas
 - Horizontal drainage: Reused existing culverts on the road, extending the culverts and construction new box culvert at station Km1 + 480
- Lighting system: Arrange lighting along the sections passing through densely populated areas
- Traffic safety: Complete traffic safety system according to National Technical Regulations on road signs QCVN 41: 2016 / BGTV

Completion Period: 12 months

3. **National competitive bidding** will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure and is open to all bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:
- Participation in at least two (2) contracts that have been successfully or substantially completed within the last five (5) years and that are similar to the proposed works, where the value of the Bidder's participation exceeds VND 125,000,000,000. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section VII (Works Requirements).
 - Submission of audited financial statements or other financial statements acceptable to the Employer, for the last three (3) years to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year, calculated as the difference between total assets and total liabilities should be positive.
 - Minimum average annual construction turnover of VND 314.000.000.000 calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
 - The Bidder must demonstrate access to, or availability of, liquid assets, lines of credit, or other financial resources (other than any contractual advance payments) to meet the Bidder's financial resources requirement for (i) its financial obligations for its current contract and (ii) the total requirement for the Subject Contract of VND 50,000,000,000.

The qualification criteria are more completely described in the Bidding Document.

5. A complete set of Bidding Documents in Vietnamese is freely available on Vietnam National e-Procurement System (www.muasamcong.mpi.gov.vn) until 10:00 hours on 13 August 2019.
6. e-Bids must be submitted via Vietnam National e-Procurement System **at or before 10:00 hours on 13 August 2019**. Late bids will not be accepted. Bids will be opened online at 10:00 hours on 13 August 2019.
7. All bids must be accompanied by a Bid Security as described in the Bidding Document.
