1. The Socialist Republic of Vietnam has received financing from the Asian Development Bank towards the cost of **Greater Mekong Sub-region Corridor Town Development Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. **Quang Tri Department of Planning and Investment** now invites sealed bids from eligible bidders for **Construction of** and Installation of Solid Waste Collection and Treatment System in Huong Hoa District, Quang Tri province, Vietnam.

- **Description of Work:** Construction and Installation of Solid Waste Collection and Treatment System in Huong Hoa District, Quang Tri province, Vietnam.
- **The Civil work includes 3 main components:**
 - The Sanitary Solid Waste Landfill (small scale): construction area of 4,86 ha; time for closing the Landfill: after 5 years; leachate treatment capacity of 150m³/night.day.
 - Road system: Construction of road category VI in mountainous area, with a length of 4.81 km; road basement width of 6 m, road pavement width of 3.5 m; sidewalks of 0.75 m wide on each side.
 - Construction and installation of a 22 kV Electric system and a Transformer: The length of the Electric system of 4.33 km.
- **Construction time:** 18 months.

3. **National Competitive Bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications should participate in this bidding:

- All pending litigation and arbitration, if any, shall be treated as resolved against the Bidder and so shall in total not represent more than 50 percent of the Bidder's net worth calculated as the difference between total assets and total liabilities.

- Minimum average annual construction Turnover of VND 175 billion (175.000.000.000 VND) calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
- Participation in at least two (02) construction contracts that have been successfully (attachment with the Minutes on completed Work Quantities and putting into use) or substantially completed (*is understood as execution $\geq 80\%$ of total contract value and attachment with Accepted completed Work Quantities*) within the last 5 years, prior to the deadline for bid submission and that are similar to the proposed works, where the value of the Bidder's participation of each contract exceeds VND 100 billion (100.000.000.000 VND).

The qualification criteria are more completely described in the bidding documents.
