1. The Government of the Socialist Republic of Vietnam has received financing from the Asian Development Bank (hereinafter called "ADB") toward the cost of the **Secondary Cities Development Project**. Part of this financing will be used for payments under the contract package named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Projects Construction Investment Management Authority of Quang Nam Province** ("the Employer") invites sealed bids from eligible Bidders for construction of class II road and bridges in Tam Ky city, which has total length of 1,796.42m (Begin point: rescue road, End point: Tam Thanh sea dyke):

The scope of works includes:

- Bridges with spans includes eight (8) super-T beams, Ltc = 330.5m.
- Road approaches has two lanes, speed design is 80km/h, length 1,469.9m

3. **National competitive bidding** will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Experience:

- Participation in at least one (1) contract within the last three (3) years that have been successfully or substantially completed and that are similar to the proposed works which deems to include traffic work (plain road/bridges) of class II or higher, and the value of the Bidder's participation exceeds VND 146,000,000,000.

Financial:

- Minimum average annual construction turnover of VND 350,000,000,000 calculated as total certified payments received for contracts in progress or completed, within the last five (5) years (2013, 2014, 2015, 2016, 2017).
- Bidder must demonstrate access to, or availability of, liquid assets, lines of credit, or other financial resources (other than any contractual advance payments) to meet the Bidder's financial resources requirement for the subject contract of VND 45,700,000,000.

The qualification criteria are more completely described in the Bidding Document.

 - Pay a non-refundable fee of VND 2,000,000 by cash.
7. Deliver your bid:

 - **On or before 8:00 hours on 1 October 2018.**
 - All Bids must be accompanied with a Bid Security as specified in the Bidding Documents.
 - Late bid shall be rejected. Bids will be opened immediately after the bid submission deadline at the above-mentioned address (para 5) in the presence of Bidders' representatives who wish to attend.
