1. The Government of the Socialist Republic of Vietnam has received financing from the Asian Development Bank (hereinafter called "ADB") toward the cost of the **Urban Environment and Climate Change Adaptation Project**. Part of this financing will be used for payments under the contract package named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Provincial People's Committee of Quang Binh** represented by **Dong Hoi City Environment & Climate Change Project Management Unit** ("the Employer") invites sealed bids from eligible Bidders for the **Package DH/W4: Construction of Horizontal Road No. 3 (36M: KM1.387-2.919)**.

The scope of works includes:

- Construction of the asphalt concrete Road with the total length of L = 1,532m, width of 36m. Drainage and Wastewater sewer system along the road: diameter from 160mm to 1500mm with a total length of 5,000m; Power supply (electricity and Lighting); cable tunnel; stone embankments with quantity over 1,600 m³ for two (2) lakes.
 - Planting trees and greenswards along the divider and sidewalks along the road.
3. **National competitive bidding (NCB)** will be conducted in accordance with the ADB's [Single Stage – One Envelope](#) bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
 4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Experience:

- Participation in at least a **contract** that has been successfully or substantially completed within the last **five (5) years** up to the time of bidding closure which are similar to the one currently being tendered, where the value of the Bidder's participation in each contract has made at least **VND 130,000,000,000**.

Financial:

- Minimum average annual construction turnover of **VND 93,000,000,000** calculated as total certified payments received for contracts in progress or completed, within the last **three (3) years** (2015; 2016; 2017).
- Financial Resources Requirement for Subject Contract: **VND 11,700,000,000**.

The qualification criteria are more completely described in the Bidding Document.

5. Interested eligible Bidders may obtain further information from the Employer and inspect the Bidding Document starting on 8 November 2018 from 8:00 to 16:30 hours during Mondays to Fridays (except during weekends and holidays) until before 9:00 hours on 10 December 2018, at the address given below:

 - Pay a non-refundable fee of VND 2,000,000 by cash.
7. Deliver bids:

 - On or before **9:00 hours on 10 December 2018**.
 - Together with a Bid Security as specified in the Bidding Documents.

Late bid shall be rejected. Bids will be opened immediately after the bid submission deadline at the above-mentioned address (para 5) - **No. 34, Tran Quang Khai Street, Dong Hoi City, Quang Binh Province** - in the presence of Bidders' representatives who wish to attend.
