1. The Social Republic of Vietnam has received financing from the Asian Development Bank (hereinafter called "ADB") toward the cost of the **Second Greater Mekong Subregion (GMS) Corridor Towns Development Project**. Part of this financing will be used for payments under the contract package named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Bac Giang City's People's Committee represented by Bac Giang City's Construction Project Management Unit No.2** ("the Employer") invites sealed bids from eligible Bidders for the **Package BG5: Wastewater Treatment Plant Extension**.

The scope of works includes:

- Construction of newly wastewater treatment cluster: Pre-treatment house; integrated tank for biological treatment and secondary sedimentation; Sludge treatment system; Disinfection system; other auxiliary works.
 - Improve the existing wastewater treatment cluster: Pre-treatment house; Improved OCO biological treatment tank; Sedimentation tank; Contact tank; Auxiliary works.
 - Equipment: Installing equipment for pre-treatment house; Installing equipment for biological and sedimentation tank; Installing equipment for mud treatment; Installing equipment for air-blowers, chemical houses, contact tanks.
 - Installing equipment to measure pressure, air flow, wastewater flow, and others; SCADA system, monitoring system, experiment, fire protection equipment, generators, electrodynamics system, office equipment.
3. **International competitive bidding (ICB)** will be conducted in accordance with the ADB's [Single Stage – One Envelope](#) bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
 4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Experience:

- Participation in at least one (1) contract that have been successfully or substantially completed within the last five (5) years and that are similar to the proposed works, where the value of the Bidder's participation in each contract exceeds VND 130,000,000,000.
- Each Partner of a Joint Venture: Participation in at least one successfully or substantially completed contract of similar nature where such partner's value of participation exceeds VND 32,500,000,000.

Financial requirements:

- Minimum average annual construction turnover of VND 261,000,000,000 calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
- Financial Resources Requirement for Subject Contract: VND 33,000,000,000.

The qualification criteria are more completely described in the Bidding Document.

- Together with a Bid Security as specified in the Bidding Documents.

Late bids shall be rejected. Bids will be opened immediately after the bid submission deadline at the above-mentioned address in the presence of Bidders' representatives who wish to attend.
