

Invitation for Bids – Rebidding

1. The Social Republic of Vietnam has received financing from the Asian Development Bank (hereinafter called "ADB") toward the cost of the **Green Secondary Cities Development Project**. Part of this financing will be used for payments under the contract package named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Program Coordination Office of Commodity- oriented Poverty Reduction Program in Ha Giang Provincial** ("the Employer") invites sealed bids from eligible Bidders for the contract package **HG-CW02: Upgrading and expanding the National Road No.2 (from Km285+995 to Me new bridge) and constructing new bridge passing Lo River to connect the National Road No.2 (at Km286+450) with southern ring road (at Km2+315.31)** with the following details:

Summary of works: (i) Upgrading and widening 1,225.52 m urban main road TCXDVN 4054-2005, and (ii) Construction of the bridge crossing Lo River, prestressed RC structure, three spans 33+50+33, total length 129.2 m

Site location: Cau Me village, Phuong Thien commune, Ha Giang city

Contract implementation period: 12 months

Contract type: contract based on fixed unit price

3. **National Competitive Bidding (NCB)** will be conducted in accordance with the ADB's [Single-Stage: One-Envelope](#) bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Construction experience:

- As a minimum, the Bidder's net worth for the last year, calculated as the difference between total assets and total liabilities should be positive.
- Participation in at least one (1) contract that has been successfully or substantially completed within the last five (5) years and handed over and operated, each with a value of VND 122,000,000,000 or more. Similar nature of the contracts must cover the size of the items of complexity, method, technology or other characteristics as described in Section VII - Construction Requirements:

- i. Construction of bridge works, grade II or higher
- ii. Upper structure: prestressed reinforced concrete continuous box girder with balanced cantilever construction combined with tower pylon, and cable-stayed system; 01 cable-stayed system with saddle on top of cable-stayed bridge tower by single tension technology.
- iii. Lower structure: bored pile $D > 1.5\text{m}$;
- iv. Total length $L > 100\text{m}$.

Financial requirements:

- The Bidder's net worth for the last year (2022), calculated as the difference between total assets and total liabilities, should be positive.
- Minimum average annual construction turnover of VND 305,000,000,000 calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2020, 2021, 2022).

The qualification criteria are more completely described in the Bidding Document.
