1. The Socialist Republic of Vietnam has received financing from the Asian Development Bank toward the cost of the **Basic Infrastructure for Inclusive Growth in the Northeastern Provinces Sector Project** and intends to apply part of the proceeds toward payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The **Project Management Unit of Cao Bang Province – Department of Planning and Investment** invites e-bids from eligible Bidders for the **Rehabilitation and Upgrading of Provincial road 206 (Dam Thuy commune, Trung Khanh district) – Ly Van border gate (Ly Quoc commune, Ha Lang district), Cao Bang province.**

The contract will be completed in 24 months.

3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB's [Single-Stage: One Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in the bidding:
 - Participation in at least two (2) contracts that has been successfully or substantially completed within 1 January 2014 to the time of bid closing date as an independent contractor or a joint venture member (Excluding subcontractors) and are of a nature similar to the work under bidding, in which the Bidder's participation value in each contract is at least VND 240 billion.
 - Minimum Average Annual Construction Turnover of at least VND 246 billion calculated by the total of confirmed payments for on-going or completed contracts, within the last three (3) years (2017; 2018; 2019).

The qualification criteria are more completely described in the Bidding Document.
